1. WHAT EXACTLY ARE COOKIES?

When you visit a website, a cookie is a little text file that the website saves on your computer or mobile device. This short text file may contain a unique identification that allows your computer or mobile device to be distinguished from other devices. In this Policy, we use the term "cookies" to refer to website cookies as well as similar technologies that may collect information automatically when you visit our website (such as pixel tags and web beacons).

- 1. Durations of Cookies: Cookies can be stored on your computer for varying amounts of time. "Session cookies only last for the duration of the browser session and are automatically removed when you close your browser. "Persistent cookies" cookies live after your browser is closed until a predetermined expiration date provided in the cookie (as determined by the party that placed it) and aid in recognizing your computer when you open your browser and browse the Internet again.
- 2. First Party and Third-Party Cookies: First-party cookies are those that are placed on a website by the site's owner, in this case, Jada Ai. Third-party cookies are set on a website by third-party providers (such as organizations that provide advertising monitoring or web analytics services) as well as by website advertisers. As explained below, we use both first-party and third-party cookies.
- 3. Pixel Tags: We also utilize pixel tags (often in conjunction with cookies) from the third parties listed below to collect information about your use of the Websites and interactions with email or other communications. Pixel tags are a cookie-like technology that can be included in online content or inside the body of an email to track

activity on websites (for example, to know when content has been shown to you) or to know when you have viewed specific content or an email message.

2. COOKIES SOURCE AND CATEGORIES

Our cookies are either first-party or third-party cookies. The website or domain that places the Cookie determines whether the Cookie is 'first' or 'third' party. In the context of this Cookies Policy, first party Cookies are those set by us, and all information gathered from such Cookies is received by us, whereas third party Cookies are those set by third parties with whom we do business. When you visit the Websites, these parties may install unique Cookies on your browser to gather information about your use of the Websites and perhaps other online activities over time and across multiple websites and apps. These third parties acquire data directly from your web browser and process it in accordance with their respective privacy policies. Depending on their lifespan, first or third-party Cookies are classified as 'persistent' or 'session' Cookies:

- 1. Persistent cookies are retained on your device between browser sessions and allow us to remember your preferences or actions across the websites (or, in some situations, across many websites). Persistent Cookies can be used for a variety of objectives, such as remembering your preferences and selections when using the Websites or targeting advertising. These Cookies do not expire when your browsing session ends and remain on your device until an expiration date defined by the Cookie's provider, unless you disable this.
- 2. Session Cookies: We can relate your actions throughout a single browser session thanks to session cookies. A session begins when you open a browser window and ends when you exit the browser window, at which point all session cookies are destroyed. These Cookies may be used for a variety of purposes, including remembering what you clicked on, on the previous page you visited.

1. HOW ARE COOKIES USED?

It is crucial to note that different Cookies perform different functions; the list of Cookies used on the websites is provided below.

Necessary Cookies

These Cookies are required for the websites to function properly; they allow you to navigate the websites and enjoy their features. You would be unable to

navigate between pages or use certain essential functions of the websites if these were not there. If you do not want us to gather such information, you must immediately stop using the websites. By continuing to use the websites, you agree that these Cookies are required for the provision of such services and will be set on your browser as is customary..

Targeting or Advertising Cookies

These Cookies are used to offer more relevant information to you and your interests. They may be used to offer tailored advertising or to limit the number of times an advertisement is displayed to you.

Functionality Cookies

These Cookies enable the websites to remember if you have previously visited the Websites as well as the choices you make (such as your language, region, or preferences) so as to give you a more personalized online experience.

Performance Cookies:

These Cookies gather and report on aggregate non-identifiable information, which assists us in understanding the performance of the websites and gives insights into how the website is currently used and how it might be improved for users. These Cookies save information such as the sections you have visited, the amount of time you have spent on the websites, and any problems you have encountered, such as error messages.

4. HOW TO MANAGE COOKIES.
